

The Destruction of Humanity by the Sword of Shariah:

Pastor Youcef Nadarkhani's Cry for Help to Stay an Imminent Execution

The democratic institutions and freedoms of Western Civilization are under fire in the 21st Century from dark forces demanding the imposition of Shariah law. These Islamists and pro Shariah law advocates seek to destroy the very essence of God given freedoms and liberties known by individuals in Western Civilization. While these dark forces of Shariah law purport themselves to be peaceful and tolerant, the record of their actions is replete with countless examples over centuries demonstrating violence, intolerance, aggression and murder of innocent women, men and children. If a miraculous intervention does not occur in staying his execution, Nadarkhani will leave behind a widow and two fatherless children.

These dark forces of Shariah law seeking to destroy an innocent Iranian Christian family are also deeply entrenched in the United States. Where is the public outcry from the Council on American Islamic Relations, the Islamic Society of North America and imams in the United States to condemn the brutality of illegal Sharia application against an innocent Christian pastor in Iran? Their silence is a deafening roar; however, the silence is no surprise since the Council on American Islamic Relations and Islamic Society of North America are known fronts for the Muslim Brotherhood. The creed of the Muslim Brotherhood is the following: "God is our objective; the Koran is our constitution; the Prophet is our leader; jihad is our way; and death for the sake of God is the highest of our aspirations." In “An Explanatory Memorandum on the General Strategic Goal for the Group in North America” the modus operandi of the Muslim Brotherhood was delineated by senior leader Mohamed Akram in May 1991: “The Ikhwan [Brotherhood] must understand that their work in America is a kind of grand jihad in eliminating and destroying the Western civilization from within and ‘sabotaging’ its miserable house by their hands and the hands of the believers so that it is eliminated and God’s religion is made victorious over all other religions.” The ideology of the Muslim Brotherhood and their strict adherence to Shariah law are completely incompatible with the United States Constitution. The ideology of the Muslim Brotherhood is the antithesis of all certain unalienable Rights endowed by our Creator, that among these are Life, Liberty and the pursuit of Happiness.

Nevertheless, ten years post 11 September 2001, the Muslim Brotherhood continues to grow in strength and recognition in the United States with high ranking members of the Muslim Brotherhood deliberately appointed by President Barack Obama to positions in his administration at the expense of the taxpayers. These dark forces of Shariah law have already gained a foothold in the United States legal system, where Shariah law application has been implemented in cases in the appellate court system. While President Obama has condemned the current situation in Iran with Pastor Nardarkhani, his continued appointments and embrace of the Muslim Brotherhood are ominous red flag warnings. The Muslim Brotherhood is re-establishing its global caliphate while the leadership and influence of the United States wanes to the detriment of non-Muslims living in the Islamic world.
